3. How will the recommendations help us meet our strategic priorities?

3.1 The review will assist in achieving good governance and meeting the priority for an efficient Council.

4. Key issues

- 4.1 Following the adoption of the Leader and Cabinet Model at Forest Heath District Council in May 2012, it was resolved to undertake a review of the new governance arrangements after six months. Cabinet agreed in September that this work should be undertaken alongside the ongoing governance review to align the constitutions of both authorities by May 2013.
- 4.2 The review has focused on the practicalities of the new arrangements, how things were bedding in for Members and officers and amendments/adjustments could be implemented to improve the arrangements. The review included consultation with a range of Members and officers on how the new governance arrangements were working so far. All Members were invited to comment and feedback was received from 12 Members (including all Cabinet Members) together with a selection of Heads of Service and Service Managers.
- 4.3 The results of this consultation have been incorporated into an Overview of Key Issues, the main points of which, arising from Member Comments, are set out in the Appendix attached.
- 4.4 Further issues of detail were also raised by officers. Some of these are addressed in changes to the Constitution. Others will be a part of the further review in May next year which will see more work toward alignment across both Forest Heath and St Edmundsbury. In particular please note the amendment to the definition of a Key Decision so that it relates to a spending of over £25k if not_specifically_mentioned_within_the_approved_Revenue_Budget_or_Capital_Programme.
- 4.5 It is also proposed that the requirement to video record all Council and Committee meetings is removed to allow greater flexibility in meetings, both with regard to the layout and the location. In terms of layout this will enable changes to layout without the need to ensure the reprogramming of video equipment. The ability where appropriate to hold committees in other venues will also help Community Engagement. It is suggested that the Protocol be changed to state that meetings will normally be recorded but this may be amended with the agreement of the Chairman where appropriate.
- 4.6 The Constitution has also been updated as required to meet the changes made in respect of individual matters where there has been agreement by Council over the last 6 months and to reflect responses to specific concerns raised during the review process.
- 4.7 This has been considered by Joint Leadership Team before this meeting and a detailed list of suggested amendments to the constitution as well as any other necessary actions, updated as necessary, will be considered by Council on 12 December. Those issues that cannot be resolved by December will be incorporated into the 12 month review due to be considered in May 2013.
