KEY DECISIONS

857. MILDENHALL DOME LEISURE CENTRE (REPORT NO CAB14/127) (Decision Plan Reference: Nov13/07)

The Cabinet Member for Health, Leisure and Culture presented this report which explained that the Mildenhall Dome Leisure Centre was managed under the terms of a 2001 Legal Agreement which had to be amended as a result of Mildenhall College gaining academy status and transferring from the responsibility of Suffolk County Council to the Academy Transformation Trust in July 2013.

This report sought authority for Officers, in consultation with the Portfolio Holders, to agree and implement the new Agreement in time for the budget setting in February 2014, working closely with the College and Suffolk County Council.

The new Agreement would also encapsulate the wider aims of the Mildenhall Hub project, which included plans for the long-term replacement of the leisure facilities in Mildenhall.

With the vote being unanimous, it was

RESOLVED:

That the Director, in consultation with the Leader of the Council, the Portfolio Holder for Health, Leisure and Culture and with Anglia Community Leisure (ACL), be authorised to:

1. Negotiate, sign and implement a new Management Agreement for the Mildenhall Dome Leisure Centre ending no later than 30 June 2018, provided that the terms of the new Agreement are consistent with the aims of the Mildenhall Hub Project and the Council's Medium Term Financial Strategy.

2. The Council's Management Agreement with Anglia Community Leisure be amended accordingly, if required.

NON KEY DECISIONS

858. DRAFT WEST SUFFOLK FAMILIES AND COMMUNITIES STRATEGY (REPORT NO CAB14/128) (Decision Plan Reference: Nov13/02)

The Cabinet Member for Families and Communities presented this report which explained that the West Suffolk Families and Communities Strategy (as set out in the Appendix to this report) provided the framework for reshaping the relationship between the Council, its communities and their families. It aimed to foster resilience in local communities and sought to address the dependency culture which could build up when the Council was seen as the first port of call for any issue. It also deliberately focused on supporting families as providing support early, was a preventative approach which was both better for the families and reduced the demand placed on public services by those in crisis.

The approach outlined was founded on an asset-based approach to working with communities which focuses on the strengths a community already had and could build on, rather than a focus on deficits or problems. It was based in the knowledge that sustainable local solutions could only come from the communities themselves, not from Council generated projects.

At a time of scarce resources it sought to focus resources within communities where the greatest impact could be provided. The thinking behind this Strategy had been reflected in the creation of a Families and Communities Team as part of the Leisure, Culture and Communities restructuring. This Team would provide Locality Officer support to Councillors across both Councils in delivering projects.

This Strategy had also been considered by the Overview & Scrutiny Committee at their meeting on 19 December 2013, where it had been recommended for adoption by the Council.

With the vote being unanimous, it was

RECOMMENDED:

That the West Suffolk Families and Communities Strategy be adopted.
