8. Parish Conference: Debrief

Following the Parish Conference on 12 May 2011 a debrief will be undertaken and planning for the Autumn conference will commence. The Management Support Officer will verbally updated the Working Party.

9. Rural Bus Cuts: Identify Practical Solutions

Representatives from Suffolk County Council, bus operators and other stakeholders will discuss the issue of rural bus cuts and identify practical solutions.

A copy of Suffolk County Council's transport solutions toolkit is attached as Report **C21**.

10. Street Lighting

Suffolk County Council (SCC) is shortly to embark on a project to make all street lighting controllable in respect of timing and light level output.

SCC is to invest £2.5 million to install an intelligent lighting system to over 55,000 street lights. This will enable street lights to be dimmed and lighting hours to be controlled from a central location. Overall the investment will deliver annual savings on energy costs approaching £500,000 and carbon reductions of over 4,000 tonnes per annum.

The proposals would as a rule see lighting turned off in residential areas, between midnight and 5.30am and dimmed in other areas.

There are certain locations where close examination of lighting levels and operating times needs consideration such as town centres, major junctions, public car parks and indeed residential areas. SCC are proposing to draw up initial proposals and hold local meetings to allow all those interested (Police, Borough/District, Town and Parish Councils, residents, businesses and including Borough Councillors) to have input in order to draw on their local knowledge.

A presentation on the proposals will be made at a meeting by Richard Webster, Electrical Services Manager, Suffolk County Council.

Recommendation

12. Rural Post Offices: Benefit Cheques

The facts

- (a) currently 'green giro' benefit cheques can be cashed at Post Offices, however the Government recently awarded PayPoint, a private sector company, the contract.
- (b) from 2012 (no official date has been issued yet) those people wishing to cash their DWP (Department for Work and Pensions) benefit cheques will only be able to do so at a PayPoint outlet.
- (c) change will not affect the majority (98% nationally) of benefit recipients who receive their payment directly into their bank account those without access to a bank account can receive their cash via a Post Office card account, a very basic form of bank account, if they wish to continue to use and support their local Post Office.
- (d) there are 22,000 PayPoint outlets around the country. However in St Edmundsbury very few are found outside of Haverhill and Bury St Edmunds.

Potential benefits

- (a) the DWP state it would save taxpayers millions of pounds cashing and processing cheques costs £30 million a year.
- (b) PayPoint outlets are often open on Sundays and in the evenings, unlike many Post Offices.

Potential concerns

- (a) benefit recipients will have to access the PayPoint system through a swipe card or barcoded bill, which may cause difficulties for some vulnerable people (most people who had opted for the giro system were unable or unwilling to cope with electronic banking). Of the 250,000 to 350,000 estimated recipients of 'green giros' in the UK, around 60,000 are pensioners.
- (b) PayPoint outlets may not be as conveniently located as existing Post Offices.
- (c) Post Offices will lose income and potentially visitors. The National Federation of Sub-Postmasters has expressed its fears to the Government about the potential impact on the Post Office network.

The specific impact for St Edmundsbury

- (a) the Borough Council does not pay anyone their housing benefit payment via a 'green giro' the majority now receive their payment via BACS. A small minority receive payment via a 'crossed cheque' that can be cashed at any bank.
- (b) the change will affect those residents who still receive their DWP benefit payments by cheque. They will need information and support from the DWP and other agencies to assist them in the transition.

(c) local Post Offices may also want to advise their customers on switching to means of payment that still allow access to their money at the Post Office itself. For instance, as well as the Post Office's own card account, a large number of high street bank accounts can now be operated free of charge at Post Offices.

Recommendation
