3. Corporate Priorities

4. Key Issues

- 4.1 **HAVERHILL RECYCLING CENTRE FIRE on 27 February 2012:** Due to the nature of the site the fire smouldered for a number of days and there were complaints from the local area about the smoke. In response, SEBC Environmental Health Officers liaised with Suffolk Fire and Rescue Service.
- 4.2 **SEVERE RAINFALL on 3 May 2012:** A small number of properties in the Newmarket area were affected as a result of issues in the area of the No. 1 Drain.
- 4.3 **CASTLE HILL SCHOOL FIRE on 3 June 2012:** A fire at a derelict school in Haverhill, led to concerns over asbestos waste. SEBC Environmental Health Officers liaised with Suffolk Fire and Rescue Service to alleviate concerns. It was difficult to get in touch with the Out of Hours service over that weekend due to telephony issues which were resolved on the Monday morning.
- 4.4 **CUPOLA HOUSE FIRE on 17 June 2012:** A major fire at premises in The Traverse, Bury St Edmunds occupied by Strada restaurant that resulted in significant impacts on local businesses and residents. The longer term Recovery aspects are still being addressed and a verbal update on the Multi-Agency Debrief and Lessons Identified session held on Friday 28 September 2012 will be provided at the meeting.
