1. Living it UP in West Suffolk

1.1 An event was held on Thursday 31 January at the Arts Centre Haverhill to promote falls prevention and general wellbeing in older people through the winter months. The event was supported by 26 partner organisations including the Warmer Homes, Healthy People Team. Members of the public were provided with free refreshments and a healthy lunch from Healthy Ambitions Suffolk. Fifty local people attended and the feedback from both stall holders and visitors was very positive.

2. ONE Haverhill

- 2.1 A great deal of work has been going on to prepare for the Neighbourhood Community Budget. Work on the Young People's Strategy is going well with a number of existing groups working with young people agreeing to merge into one to ensure that all the conversations are had in one place. In addition Job Centre+ have secured funding for a year for a co-ordinator post to pull together what is available in terms of activities, services, skills development and work opportunities for young people. The post-holder will improve the awareness of young people and those working with them of what is already available in the
- 2.2 On the public realm side of the pilot there are a variety of practical improvements which are being explored. For example, creating a co-ordinated inspection regime to cover a range of services so we spot problems earlier and solve them together, and opportunities for residents to be involved at a

practical level in helping to keep their neighbourhood tidy by way of a community volunteer scheme. More details on both strands of work will be available on the ONE Haverhill website after the 8 February meeting of the ONE Haverhill Board.

3. Haverhill Community Centres

- 3.1 Discussions continue with a local charity which is expressing a strong interest in negotiating with the Council for the transfer of the Chalkstone centre. A little more work is required to ensure an appropriate model of governance is worked up. This must include representation for local people on the group to be formed to take on the centre. Once this work has been done we will be able to share with you details of the group involved.
- 3.2 Sadly the current Community Association at the Leiston Community Centre has reached the conclusion that it can no longer run the centre. The association is primarily made up of users of the centre and, after four years of excellent work clearing historic utility debts and greatly improving the internal appearance of the centre, the current volunteers understandably feel they have served their time. With no new volunteers responding to the call for help at an Emergency General Meeting they have given the Council six months' notice that they will return the lease of the centre. We are currently in the process of following up interest from Haverhill Town Council in keeping the centre available as a community facility, and I will update you if this interest results in a definite proposal.

4. <u>Business Regulation and Licensing</u>

4.1 Following the successful bid for external funding from the Food Standards Agency to implement changes to the way the team captures and reports information relating to their food sampling activities, the necessary software updates are now complete. Members will recall that the new system will ensure that all food sampling results are shared nationally and will allow the team access to other authorities' results. This will enable the team to better target resources and identify foods which should be included in the sampling programme.

5. Environmental Health

5.1 <u>Fuel Poverty</u>

- 5.1.1 The Suffolk Climate Change Partnership, of which the Council is a partner, successfully bid to the Department of Climate Change and Energy to fund home improvement measures for vulnerable people. The funding provision is worth £165,000 across Suffolk.
- 5.1.2 This time-limited funding sits alongside a successful Department of Health Warm Homes Healthy People bid aimed at reducing the risk of cold-related illness or early death in vulnerable Suffolk residents living in cold homes over winter 2012-13. The proposal incorporates a range of free interventions including:
 - (a) targeted winter warmth campaign;
 - (b) face-to-face support leading to rapid interventions to improve occupants' living conditions; and
 - (c) services delivering immediate health/wellbeing improvements.

- 5.1.3 It is estimated there have been on average 409 'excess winter deaths' in Suffolk each year (source: NHS Suffolk). This affects people of all ages, with the most vulnerable being those over 75, especially those living alone and suffering from chronic illnesses.
- 5.1.4 Both funding bids were co-written by the West Suffolk Environment Team which is also leading key elements of the services being delivered.

6. <u>Strategic Housing and Homelessness</u>

- 6.1 Home-Link Re-Registration Process
- 6.1.1 The Home-Link re-registration process is under way. All applicants on the Council's Housing Register, Home-Link, need to update (re-register) by the end of March 2013, in accordance with the changes to the Council's Allocations Policy. The new Allocations Policy comes into effect on 1 April 2013. Applicants are being assisted by the Housing Options Team to complete the re-registration process on-line, with increased staff availability at the Council's offices and on the telephone. A briefing session for Members is being planned for the end of March, but no firm date has been set as yet.
- 6.2 Temporary Accommodation Working Group
- 6.2.1 Cllr Burt (Cabinet Member for Housing at Forest Heath District Council) and I have set up a West Suffolk Temporary Accommodation Working Group which had its first meeting on 7 February. The group is looking at the level of demand for temporary accommodation; statutory obligations; work with other providers; how people access services; and funding streams with a view to developing a West Suffolk strategy to ensure the best use of the accommodation available across West Suffolk. We have asked officers to map the current availability and type of accommodation and to look at opportunities for extending the options available to homeless and other vulnerable people.
