1. Purpose of the Report

- 1.1 The Council requires that monitoring its representation on outside bodies is either undertaken by the Grant Panel, where that organisation receives a grant from the Council, or by the production of an annual report full Council.
- 1.2 The annual report to full Council is produced after consideration by the Democratic Renewal Panel.
- 1.3 Attached as Appendix A to this report is a copy of the Annual Report form and Appendix B is the list of representatives who received a request to complete the form.

2. Forms Returned

- 2.1 Appendix B has been annotated to record those forms that have been returned.
- 2.2 Of 57 forms requested, 34 have been received, 23 (40%) have not been returned. However, it should be noted that returns have been received in respect of 30 organisations out of the 33 requested (91%).

3. Annual Report 2009/2010: Summary of Key Points Raised

- 3.1 The aims of the Annual Report are to summarise any issues arising from the individual reports compiled by Members. These included those instances when it is not thought appropriate to continue appointing a representative, summarising achievements of each organisation and the contribution towards the Council's corporate priorities.
- 3.2 No return recommended that the Council should no longer be represented on an outside body. Indeed the vast majority of the representatives were positive or very positive about the benefits of Borough Council representation.
- 3.3 Representatives on Safer Neighbourhood Teams in particular felt it was valuable to establish contact and liaise with police and other agencies involved in dealing with Crime and Disorder. However, the operation of these Teams is currently under review by the Police.

Representation on Outside Bodies: Annual Report 2008/2009

1. Purpose of the Report

- 1.1 The Council has charged the Democratic Renewal Panel to compile an Annual Report 2008/2009 from reports made by its representatives on outside bodies.
- 1.2 The aims of the Annual Report are to summarise any issues arising from the individual reports, including those instances when it is not thought appropriate to continue appointing a representative, to summarise achievements of each organisation and the contribution towards the Council's Corporate Priorities.

2. Forms Returned

2.1 Of 59 forms requested, 39 have been received, 3 are now not required and 17 (29%) have not been returned.

3. Annual Report 2008/2009: Summary of Key Points Raised

- 3.1 No return recommended that the Council should no longer be represented on an outside body. Indeed the vast majority of the representatives were positive about the benefits of Borough Council representation.
- 3.2 Representatives on Safer Neighbourhood Teams in particular felt it was valuable to establish contact and liaise with police and other agencies involved in dealing with Crime and Disorder.
- 3.3 There was overwhelming support for the work of Safer Neighbourhood Teams and the representation allocated by the Council.
- 3.4 The Council nominates an officer to support the Member representative on the outside body. This is to enable the Member to be briefed but also to enable the Member to discuss issues arising from meetings with the officer which may be of particular relevance to the Borough Council. Several representatives stated that they were unaware of the identity of their support officer and, therefore, this two way flow of information is not occurring.
- 3.5 It was suggested that the Council should have two representatives on the St John's Centre Trust. Currently there is just one and the representative is making enquiries.
- 3.6 The requirement of a Borough Council representative on the Mid Anglian Enterprise Agency (MENTA) needs to be determined.

4. Recommendations

4.1 It is **RECOMMENDED** that:-

- (a) the Councillors who have yet to make their returns be reminded to do so;
- (b) the requirement that a Borough Council representative on the Mid Anglian Enterprise Agency (MENTA) needs to be considered;

- (d) all forms returned by the Council's representatives continue to be viewed on the Intranet under 'Members' Corner'.
