3. Corporate Priorities

4. Key Issues / Report

4.1 Delivering and setting the 2012/2013 Member Development Programme

- 4.1.1 The programme of events has been developed reflecting the areas identified through the Training Needs Analysis (TNA) and Corporate Priorities.
 Appendix A shows the programme of delivery as set up to date.
- 4.1.2 Following up on requests from Members another visit to Anglia Revenues Partnership (ARP) hosted by Sharon Jones and her team was arranged and four Members visited Breckland House, Thetford. This session proved to be an excellent introduction to the October afternoon session at West Stow that covered Local Government Finance and Customer Access. The session was led by key officers, and the first session presented updates to Business Rates and Council Tax and the impact of the Localism Act. This was followed by an interactive session on the proposed re-engineering of customer access. Members had the opportunity to discuss the results of consultation work and the impact of change. Following up on feedback from this session Members appeared to appreciate the format; they engaged in the planning process and enjoyed the contact with front line staff. It was also seen as a good opportunity to facilitate discussion across the Councils and led to greater understanding of the local implications of decisions made. Given the success of this model of delivery we hope to replicate this in the future.
- 4.1.3 Where possible prior to attendance at events, Members are sent relevant documents, along with internet and intranet links designed to support understanding of the subject areas. Follow-up documentation is also sent out on request to those unable to attend or in some instances, rather than take away reams of paper, access links to documents and presentations are provided.
- 4.1.4 The speed reading event on 7 December 2012 is an all day skills facilitation session which is open to Members and officers, the cost of which will be calculated on a per capita based on attendance.
- 4.1.5 The attached diary of events at **Appendix A** shows the dates for IT drop in surgeries. These "software surgeries" have been scheduled prior to main meetings, and the aim is to allow Members to drop in and discuss any specific skills requirements on Microsoft Office programs including Outlook, Word, Excel and PowerPoint on a one to one basis. The New Standards training held on 27 November 2012 will be repeated at FHDC in January to ensure all Members have the opportunity to attend. West Suffolk House is hosting the national awareness training on Gypsy and Travellers on 28 November 2012. This is an interactive session with officers and Members invited to submit questions for a discussion session.
- 4.1.6 Following the restructure an event entitled "Understanding the Organisation" will be delivered for Members in March 2013. This will be delivered by Karen Points, Head of Human Resources and Organisational Development, supported by the Directors Liz Watts and Alex Wilson. Again I suspect this is a session that will be scheduled in at West Suffolk House and at FHDC to ensure all Members have the opportunity to attend.

4.1.7 Members were invited to log in to a Webinar, a free offer from the Local Government Information Unit. This pilot has had an excellent take-up across the country, and I suspect we will receive further offers, but doubt if they will be free. If individual Councillors receive direct offers via email and take up opportunities I would be interested in their feedback.

4.2 Recording attendance and evaluating quality of Member Development Events

- 4.2.1 Attendance at Events is recorded on the organisation database Itrent. The attached report **Appendix B1** shows the individuals who have attended events since June 2012. The report at **Appendix B2** shows an example report for an individual. This report can be created for all Members at the end of the learning/financial year and sent through to them.
- 4.2.2 The new evaluation form is being used and results from these can be seen in **Appendix B3**.

4. 3 Joint Member Development Group

4.3.1 The proposed terms of reference for Forest Heath's informal Joint Member Development Group, to which Councillors Thorndyke and Mrs P Warby were nominated to join at the last meeting of the Working Party, are shown in **Appendix C**. The first meeting of this informal group will be scheduled in the New Year.

4.4 Member Development Budget - Appendix D

4.4.1 Budget 0610 1290

This budget has expenditure of only £338.50 to date due to the majority of training events being delivered by key officers internally. There is no committed budget for events commissioned in the coming months, but an estimate is £300 for speed reading dependant on attendance, £1,000 for licensing training based on last year's and £1,600 for 2 x external provision March and April 2013 to be commissioned. Economies will be achieved through the sharing of costs with FHDC.

4.4.2 Budget 0610 3850

As suggested in the last report no requests to attend conferences or seminars were received from September to 26 November 2012. It should be noted that this now means that at 9 months the budget spend is in line with expectations, standing at 73%. This budget will continue to be monitored closely in the last 3 months.


