Rural Area Working Party 9 November 2011

St Edmundsbury Borough Council's Support to Rural Voluntary and Community Groups

1. Background

- 1.1 When the 2011 Rural Area Working Party Work Programme was being developed, a Councillor requested that officers investigated possibilities of how the Council can enhance the support that it offers to rural voluntary and community groups.
- 1.2 Since Council resources are limited, and given that the Council already supports rural voluntary and community groups in various ways, it was felt that officers must do more to ensure that the support and advice that is already available is fully understood by the groups that may benefit from this support.
- 1.3 The officers have, therefore, produced a draft leaflet which is attached as Appendix A to the report.
- 1.4 The intention is for this leaflet to be distributed to as many rural groups as possible, with support from rural Ward Members. It will also be made available on the Council's website.

3. Recommendations

- 3.1 The Working Party is asked to **RECOMMEND** to the Cabinet that:-
 - (1) the leaflet contained in Appendix A to Report C212 be approved for distribution to rural voluntary and community groups in St Edmundsbury; and
 - (2) the Economic Development Manager, in consultation with the Chairman of the Rural Area Working Party, be authorised to make minor spelling, grammatical, factual and formatting amendments, provided they do not materially affect the substance or meaning of the leaflet.
