Rural Site Submissions

During the last period of consultation for the Vision 2031 documents that ran from the 1st March to 30th April 2012 the Borough Council carried out a further call for sites that developers or landowners would like allocating in the local plan. Nine submissions were received and were subsequently reported to Sustainable Development Panel in July 2012

The three additional submissions below were made via submitted comments to the Rural Vision 2031 document. A paper reporting these comments was noted by the Rural Area Working Party at its meeting in September 2012.

SS12.13 has been included in the Rural Vision 2031 Submission document as an allocated site under Policy RV18 Great Barton, for residential and community uses.

The table below provides a summary of the three submissions. The Working Party is asked to **note** that these submissions have been made but SS12.12 and SS12.14 have not been included in the Revised Draft Rural Vision 2031 document.
