(1) The Committees and Sub-Committees listed in Paragraph 1.8 of Report No: AGM/WS/19/001 operate for 2019/2020 in accordance with the number of seats and terms of reference, as contained in Appendix C of this report (previously attached), subject to the membership of the Standards Committee being increased to 7 members;
(2) The Council agrees the political balance and allocation of seats on Committees as per Appendix A of this report (attached);
(3) The Council agrees the political balance and allocation of substitutes on Committees as per Appendix B of this report (attached); and
(4) The Council notes that based on the agreed allocations, Group Leaders have up to 14 days in which to notify the Monitoring Officer of their nominations to committee places, on which the Monitoring Officer will appoint Members to Committees.

## 1. Background / Context

1.1 The Council agenda for 22 May includes an item for the appointment of Councillors to committees on a politically balanced basis.
1.2 It has now been confirmed that Councillors have divided into 4 groups; Conservative Group ( 36 members), Spectrum Group ( 12 members), Independent Group (11 members) and Labour Group (5 members).
2. Proposals
2.1 Initial calculations indicated that as a result of the division, there is no perfect answer as to how seats should be allocated to groups, and therefore at least one group would be left with fewer seats than it was entitled to.
2.2 To resolve the situation, it is recommended to increase the membership of the Standards Committee to 7 members. This leads to the allocation of seats as attached at Appendix A, and the allocation of substitutes as attached at Appendix B.
3. Consultation and engagement
3.1 The proposals within this report have been subject to consultation with leaders of the political groups.
