# Licensing: Procedures at Hearings

- 1. The Chairman will introduce Members of the Committee and Officers present and ask all parties to identify themselves to the Hearing.
- 2. The Chairman will outline the procedure to be followed and:-
  - (a) check that all parties have received copies of relevant representations;
  - (b) ask all parties whether they wish to amend or withdraw their application or representation;
  - (c) ask the Licensing officer whether any party has submitted additional supporting information (only if all parties agree shall the material be distributed to the Sub-Committee);
  - (d) if the Licensing Officer reports any requests for a witness to appear, decide whether to allow the witness to speak and ask whether there are any further declarations of interest;
  - (e) agree how much time each person will need to present their case; and
  - (f) the Sub-Committee will determine whether the Substitute Member is required to hear the application.
- 3. The Licensing Officer will present the Statement of Facts.
- 4. The Chairman will invite Members and other parties to the hearing to ask questions of the Licensing Officer about the Statement of Facts.
- 5. The Chairman will invite the Applicant or representative to present their case and respond to questions from Members, Officers and other parties to the hearing.
- 6. The Chairman will invite those that have made objections or relevant representations to present their case and respond to questions from Members, Officers and all the other parties.
- 7. The Chairman will invite all parties to sum up their case and to confirm they are satisfied that they have said all they wish to say. (Nb the applicant should sum up last).
- 8. Members and Officers may ask any final questions and the Chairman will then give all parties an opportunity to respond on those points (Nb the last word should be from the Applicant).
- 9. The Sub-Committee, accompanied by the legal advisor and Committee Administrator will retire to determine the application.
- 10. The Chairman or legal advisor will announce the decision together with the reasons for it and will also outline rights of appeal.

## General Notes:

- (i) The hearing may be adjourned at any time at the discretion of the Members.
- (ii) Members may amend the procedure at any time if they consider it to be in the public interest or in the interest of a fair hearing.
- (iii) Members may exclude any person from the hearing if it appears to them to be in the public interest to do so or if that person is being disruptive.
- (iv) No parties will be allowed to cross examine unless Members agree that the procedure should be altered.
- (v) Any advice given in private session will be reported to all parties to the hearing.

# 1. Key issues and reasons for recommendation(s)

### 1.1 Key Issues

- 1.1.1 An application has been received for a new premises licence for LPR Express, 99 Risbygate Street, Bury St Edmunds. A copy of the application is attached as **Appendix 1**.
- 1.1.2 The application seeks the supply of alcohol for consumption off the premises during opening hours.

Opening hours are Monday-Sunday 09.00 to 23.00

A basic location plan is attached as **Appendix 2.** 

- 1.1.3 The four Licensing Objectives of the Licensing Act 2003 are set out below. Any representations for consideration must relate to one or more of these objectives.
  - Prevention of Crime and Disorder
  - Public Safety
  - Prevention of Nuisance
  - Protection of Children from Harm

#### 1.1.4 **Relevant Representations**

- (a) The application has to be advertised, both at the premises and in a local newspaper. Details are also available on the Council website.
- (b) Three accepted representations have been received and are attached as **Appendix 3**.

#### 1.1.5 **Matters for consideration**

- (a) Section 17 of the Crime and Disorder Act 1998 imposes a duty on each local authority to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent crime and disorder in its area.
- (b) If the Licensing Authority decides that this application should be refused, it will need to show that to grant the licence would:
  - undermine the promotion of the Licensing Objectives; and
  - that appropriate conditions would be ineffective in preventing the problems involved.

If the Licensing Authority cannot show the above, the application should be granted.

(c) In making their decision, Members are advised to consider the Licensing Act 2003, the Guidance on the Act and the Council's

## 1.1.6 **Other options considered**

No other relevant options were available.

# 2. Additional supporting information

## 2.1 Legal and policy implications

- 2.1.1 The Sub-Committee may take any of the steps set out below, provided they are proportionate and appropriate for the promotion of the licensing objectives:
  - (a) Grant the licence as applied for; or
  - (b) grant the licence, subject to such conditions as are consistent with the operating schedule accompanying the application, modified to such extent as the authority considers necessary for the promotion of the licencing objectives; or
  - (c) reject the whole or part of the application.

A condition is modified where it is altered or omitted or any new condition is added.

- 2.1.2 Each application should be considered on its own merits, having regard to the Council's Statement of Licensing Policy and the guidance issued under Section 182 of the Licensing Act 2003.
- 2.1.5 The decision may be appealed, by the applicant or any other party to the hearing, within 21 days of written notification of the determination made by the Sub-Committee. The Sub-Committee should state in reaching its determination those matters which it considered relevant, those matters which it did not consider as they were irrelevant, and its reasons for the decision.





I wish to express my concerns for permission being granted to the above premises for the sale of alcohol.

We are located to the rear of St Edmunds Tavern on Risbygate Street but are very aware of the large number of young adults from the college and bus station walking along Risbygate Street daily. A small number use our garden, without permission, for drinking. This is not only a public nuisance it leads to crime and disorder. We have reported several incidents of vandalism to the police. I feel that if alcohol was too readily available this problem would only get worse. I am also very concerned that the sale of alcohol 'til 11pm at night would only make matters a lot worse. I believe the increase in people potentially drinking on the street would be a public nuisance and lead to more vandalism.

The amount of empty cans which are littered about the street and our car park every day would only increase and as it is we pick up litter every morning. This would only get worse in my opinion. Please note that as a wine merchant we do not sell individual cans or bottles of alcohol so the 'said young adults' do not frequent our shop.

• College and school children frequently walk through Risbygate Street on their way to/from school and college at Lunchtime and in the evenings/mornings.

# APPLICATION FOR A PREMISES LICENCE: 'LPR EXPRESS' - 99 RISBYGATE STREET, IP33 3AA

As a resident living directly above the proposed new shop on Risbygate Street, I am writing to express my concern, reservation and opposition to the application for a premises licence in order to sell alcohol, referred to in the window of the aforementioned shop.

I live in a property immediately above 99 Risbygate Street and so I am directly affected by anything that happens in the three shops below the Rae's Yard flats. Indeed, the three flats and the three shops are managed by the same property management company – Temples - and our management fees are directly correlated to each other, based on floor space.

As such, I feel in the best position to be able to accurately express my opinion on this matter and the direct impact it will have on all the Rae's Yard residents and the residents on Risbygate Street and Tavern Lane too.

Areas where I fully expect there to be increased issues as a result of the issuing of this premises licence, in order to sell alcohol, would be:

#### CRIME AND DISORDER

With pubs and clubs within walking distance of this new proposed shop there is increased likelihood of alcohol being provided to already intoxicated individuals without the correct supervision occurring. This is already a hot topic in the press and presents an on-going issue in society.

With a public right of way right next to the shop and an open bus station and car park within 30 seconds of walking, there is already the issue of large groups of intoxicated and noisy individuals on Friday and Saturday evenings (and sometimes during the day too) and this is only going to further exacerbate this existing problem.

Furthermore, there is already a significant littering issue on Tavern Lane, Risbygate Street and Rae's Yard, with a lot of waste generated and thrown as people walk to and from the town centre on a daily basis. Offering people additional products to readily consume and then dispose of, will only increase the amount of litter which the residents of Rae's Yard and Tavern Lane will have to encounter. Evidence can be seen with a simple stroll down Tavern Lane.

With no obvious bins available, aside from those which belong to the residents, this problem cannot be easily resolved.

Finally, a business such as this, with items of stock which are inherently vulnerable to misappropriation – such as alcohol, chocolate bars, crisps, cigarettes etc. – is immediately likely to increase the risk of rising crime rate in the area.

#### PUBLIC SAFETY

As noted above, there are already issues relating to large groups of individuals found in both the open bus station and car park around this area and the extra availability of alcohol will only fuel this and make matters worse.

It is also noted that while there are similar products available at Tesco - just around the corner - at Tesco there is a security guard in place at all times on site, which acts as a safeguard to prevent alcohol being sold to large groups and already intoxicated individuals and large groups loitering outside the premises. It is unlikely this will be in place at the new shop on Risbygate Street.

In addition, there will be numerous CCTV cameras in operation at Tesco or the Co-Op which also act as a deterrent.

Furthermore, with bouncers in place at all of the nearby clubs, those who have been removed from these venues will look to shops like this for further sources of food and drink, where there is no such security in place. Meaning increased security issues for those in close proximity, i.e. the residents.

#### **PUBLIC NUISANCE**

It is noted within my leasehold agreement with Bury Town Trust, for a flat above the premises, that there is a clause relating to noise levels after 9pm. It clearly states that we are in breach of our lease if the noise levels are audible at street level after this time.

Given all the properties will be on leasehold agreements with Bury Town Trust and all will have been drawn up at a similar time with similar solicitors, one imagines there are similar clauses within them.

While on the licencing application it refers to the ability to sell alcohol to a time up to 11pm on 7 days of the week, which, to the best of my knowledge, would presumably lead to a direct contravention of the lease agreement given the likely noise levels of customers/staff at that time in the evening.

The noise levels alone would cause significant disruption to all residents on Risbygate Street and in particular those within close proximity on Rae's Yard and Tavern Lane. In particular at a time of the evening which is unsociable and not in-keeping with previous tenants in the shops in recent years.

In a business requiring regular stock replenishment, Risbygate Street does not lend itself to having regular deliveries. Parking is already a key issue and this is likely to cause further problems, or lead to deliveries at anti-social hours.

#### CHILD SAFETY

The public right of way on Tavern Lane is attached to the bus station, where everyday a significant number of children will walk by on their way to and from school. Given all of the issues noted above, having further bottles (broken or unbroken), cans (emptied or not) and other items which will have been discarded after purchase from this shop presents a real threat to these children on their way to or from school.

Furthermore, with the college only five-ten minutes away and on the walk from the college to the town centre this will only present an additional opportunity and temptation for them to attempt to buy alcohol at Lunch time or in the evenings.

In other stores located nearby, such as Tesco and Co-Op, there will be well trained and experienced staff who will have been appropriately trained to recognise and deal with underage customers. It is unlikely such extensive training will be available at a smaller, independent outfit, where there may be a significant shortfall in knowledge and experience if management are not operating the tills.

#### **AESTHETIC APPEAL OF RISBYGATE STREET**

Given the listed building status of these properties, including my own, the introduction of a shop of this nature is unlikely to do anything to improve the aesthetic appeal of these shops or the flats above them.

I would fully expect the value of the attached flats to diminish as a result of this application being accepted.

Thank you for the time taken to read my letter and I await your response. I should be grateful if you could please provide updates of the application process in due course, including results of the decision.
