# CONTEXT

## 1. Introduction

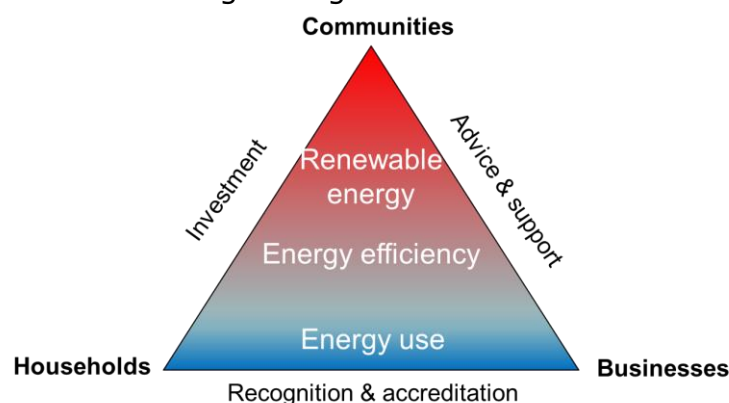
We recognise the value of working with the wider community in West Suffolk, including the commercial and voluntary sectors as well as locally significant organisations if we all are to make genuine progress on reducing CO<sub>2</sub> emissions and becoming a more climate resilient place. Our collaborative approach should also help us find resources to deliver appropriate solutions to meet the challenges.

In December 2014, the Forest Heath and St Edmundsbury Councils approved the implementation of the West Suffolk Community Energy Plan. Through our holistic approach to energy use, from energy reduction to generating your own energy, we aim for all in West Suffolk to be able to make sustainable energy choices, reduce the impact of energy cost volatility and move from fossil fuels.

## 2. Our approach

Our approach to Community Energy comprises:

- Support to residents to insulate their homes and improve energy efficiency
- Support to vulnerable residents during the winter to keep warm and well
- Resource efficiency advice and support to businesses and communities
- Capital financing to improve energy efficiency and develop renewable energy in West Suffolk – through local investment to deliver savings and generate real value to the taxpayer.



## 3. Delivering our Community Energy Plan

We already deliver some of our Plan through our participation in the Suffolk Climate Change Partnership. Additionally, we will continue to take forward other opportunities as and when appropriate, whether working on our own or together with partners in the public, private or voluntary sector.

#### **General advice available directly from the Council or via its agents/partners**

Our Environment Team can provide home energy and renewable energy advice to a range of domestic and non-domestic audiences.

In addition, we are able to refer specific enquiries to the Suffolk Community Advisor Service provided by the Suffolk Climate Change Partnership. The Service provides support to Suffolk communities on a range of issues, from advice to village hall committees on energy saving measures and renewable energy options to technical support to access funding.

#### **Home energy advice to vulnerable households**

Delivered by the Councils and our partners, Suffolk's Warm Homes Health People offers the most vulnerable householder, subject to eligibility, the following services over the winter:

- Home energy surveys- providing advice and insulation referrals
- Temporary loan of oil filled radiators
- Emergency boiler and heating repairs
- Interest-free fuel loans – administered by the Ipswich and Suffolk Credit Union
- Onward referral to wider health and support agencies through Homeshield
- Emergency fuel payments – funded jointly by Suffolk Community Foundation Surviving Winter Appeal.

#### **Warm Homes Discount**

If you are a pensioner or are classed as a vulnerable customer, you may be entitled to extra help with your gas and electricity bills during the winter months, including the Warm Home Discount Scheme. This gives a rebate to pensioners on low incomes and some other customers on low incomes.

If you are a pensioner eligible for the Warm Home Discount, the Department for Work and Pensions will try to make sure you get this discount automatically. If you are missed out, you can ask for the discount directly from your supplier.

If you are on a low income, you will need to contact your energy supplier for details of whether you are eligible. If you believe you are eligible, you will then need to apply directly to your supplier.

The Warm Home Discount Scheme is run by energy companies, who are required by law to offer this rebate. The discount won't affect your Cold Weather Payment or Winter Fuel Payment.

### **Home energy tariffs**

It is always worthwhile comparing your energy tariff with what is available from other suppliers to ensure you are getting the best deal. This can be done by contacting the energy companies directly although comparison websites can save time.

### **Collective oil buying**

Households using oil to heat their homes can choose to buy together. The social enterprise, Suffolk ACRE Community Buying Ltd, runs a bulk oil buying service to which community oil buying groups and households alike can register.

Alternatively, it is worth finding out if your community runs an oil buying syndicate.

### **Installing home energy measures**

Households and private landlords can undertake this work themselves or use installers. However, you are strongly advised to check that the installer is suitably qualified and that the work they have undertaken has appropriate warranties and quality guarantees. Reputable installers operate to certain standards laid down by various independent standards organisations such as Cavity Insulation Guarantee Agency (CIGA) for cavity wall insulation and the British Board of Agrément (BBA) for building insulation generally. Individual installers may also be members of trade associations such as the National Insulation Association (NIA). It is also advisable to obtain several written quotes to help you compare prices and quality of the work.

The Council supports the county-wide programme of home energy efficiency, Suffolk Energy Action. Households may be eligible to have some money-saving energy efficiency measures installed at a reduced cost or in some cases free of charge.

### **Feed-In Tariffs for renewable energy**

Feed-In tariffs were introduced by the Government Department of Energy and Climate Change (DECC) to incentivise small-scale low carbon electricity generation. This means that pay back times on new micro generation technologies can be made much shorter.

The reduced Feed-In tariffs, applying from January 2016 mean that the rate of return on investment is in the region of 4-5% (tax free and guaranteed for 20 years).

### **Renewable Heat Incentive**

The Renewable Heat Incentive (RHI) is a Government environmental programme that provides financial incentives to increase the uptake of renewable heat. For the non-domestic sector broadly speaking it provides a subsidy to eligible, non-domestic renewable heat generators. ### **West Suffolk Renewable Energy Feasibility Pot**

Community groups planning to install energy-generating technologies eligible for the Feed-in Tariff or Renewable Heat Incentive will be able to apply if they need help to pay for some of the preparatory costs.

The pot will pay for things like:

- Structural surveys for solar PV installations
- Legal fees for setting up leases
- Costs for setting up an Industrial Provident Society
- Running a share rights offer.

Funding will be provided as a grant only repayable when the project starts to generate income.
