We are going to be holding our 'Band Day' event, which features live and recorded music on the field, and stops at 11pm as per the existing premises license. This year we would like to continue the event later by having a 'dance tent', playing only recorded music inside a marquee, and continue to run the bar (which is also housed in a marquee). All other music - i.e. the live performances on stages used for the afternoon and evening - will still stop at 11pm, as will the on-site food vendors.
