1.1 On 27 March 2018, the Cabinet RESOLVED:

That the Housing Standards – Civil Sanctions Policy contained in Appendix A to Report No: CAB/SE/18/021, which describes the new measures and sanctions which will support existing enforcement work and pro-active inspection programmes, be adopted; and

## RECOMMENDED to COUNCIL:

That the new delegations regarding the enforcement powers be incorporated into the Scheme of Delegation, contained in Part 3 of the Constitution, to enable these sanctions to be enforced.

- 1.2 Adoption of the new Civil Sanctions Policy will enable the West Suffolk councils (Forest Heath District and St Edmundsbury Borough) to make use of new enforcement powers to tackle the small number of rogue landlords in West Suffolk and improve the wellbeing of tenants. Approval of the necessary delegations to enable the necessary enforcement powers to be exercised by appropriate officers is now sought by Council, as set out in the recommendation above in bold italics.
