The electorate for the initial option that was published for consultation did not include existing electors in Rushbrooke with Rougham (North) and therefore the 68 electors have now been included. This gives an electorate of 4544, which is 10.51% above the ideal. The boundary is considered to reflect community identity but could be further reviewed to improve electoral equality.	Feedback was received from Cllr Nettleton to move the area between Symonds Road and Mount Road from St Nicholas ward to Moreton Hall ward. This has not been implemented as the electorate figure for Moreton Hall would exceed the maximum variance.

32	St Nicholas ward	2	4080	-0.78%	Change of ward name from Eastgate & Moreton Hall North West.	Including the growth site at Rushbrooke with Rougham parish in this option received a mixed response. Those responses will be provided in full to the LGBCE. Several of those supporting the option suggested that the boundary between Moreton Hall and Rougham should be along Sow Lane.	Moving the ward boundary to Sow Lane should be considered as part of this option. It should be noted that this would have a consequential impact on the option for the Rougham ward which would adjoin this ward.
