In order to implement this the following changes have been made:- (a) Honington (Station) has moved into Pakenham & Troston ward (b) Ingham has moved into Risby ward (c) Barnham has moved into Bardwell ward.

It should be noted that a response from Fornham All Saints to the January 2018 community links survey confirmed that the Fornham parishes have a historic link to each other and also to the Culford parish. However it was not possible to include Culford in this option given their links to the other parishes in the option for the Risby ward.
