Overview

The Gatehouse centre provides a place of activity and companionship benefits to many who are elderly, living in isolation or who are facing the challenges of the onset of dementia. The Dementia Hub, provided by The Gatehouse, is the only one of its kind in St Edmundsbury. The Hub is designed to support people with dementia, their carers and the wider local community by providing practical physical and emotional support, information and advice. The hub provides volunteer and employment opportunities to those who would otherwise struggle to find work due to health and social challenges. Gatehouse has formed partnerships with the Alzheimer's Society Bury St Edmunds to address a need for dementia support services. Through fundraising sufficient funds have been raised to enable the extension/refurbishment of the Gatehouse.

Community Chest funding would be used to support the development of extended lunch clubs and new and innovative Music Therapy sessions, Exercise classes, chiropody services and additional carer support groups.

We've been around since 1986 helping those who are in need or disadvantaged. Our centre provide a place of activity and companionship benefits to many who are elderly, living in isolation or who are facing the challenges of the onset of dementia through the development of a Dementia Hub, the only one of its kind in St Edmundsbury. The Hub is designed to support people with dementia, their carers and the wider local supporting community, providing practical physical and emotional support, information and advice.

We also have a large furniture store which receives donated or recycled items that can be offered to people who are in genuine need. In addition y and we also sell to the general public to raise funds.

On behalf of partner organisations we administer the Foodbank for Bury St Edmunds, helping to meet the basic needs of individuals and families.

We try to ensure that Christmas is a time of celebration for everyone. Not only do we distribute over 300 hampers but we also extend an invitation to those who wish to have a meal, company and fun on Christmas Day.

We provide volunteer hours and employment opportunities to those who would otherwise struggle to find work due to health and social challenges.

3. About Your Project

3.1. What do you want the funding for? Please be specific. Please note that 'project' is meant to describe the project for which you are seeking funding, and not your organisation. Please include outputs (what you will deliver).

We are looking for funding towards the core costs of The Bury St Edmunds Dementia Hub. In recent years, Gatehouse has become aware that the needs of its clients were changing. "Traditional" day centre services have become less popular due to a combination of people's changing expectations, the ambition to tailor services to individual need as well as changing funding arrangements through the development of personalised budgets. However, what also became clear was the local deficiency of services for those living with dementia, both those experiencing the disease and those caring for them. There is limited and sadly diminishing levels of community support locally for those at the early stage of the illness as well as a lack of access to information and support for their loved ones.

Gatehouse has formed partnerships with the Alzheimer's Society Bury St Edmunds to address this need and has forged links with other organisations in the area such as Sue Ryder & Age UK Suffolk.

Through fundraising we have raised sufficient funds to enable the extension/refurbishment of our building that will enable us to meet the needs of more people with dementia and their carers including those with restricted mobility and more challenging behaviours.

If successful Community Chest funding will be used to support the development of extended lunch clubs and new and innovative Music Therapy sessions, Exercise classes, chiropody services and additional carer support groups.

There is internationally a body of research and experience identifying that physical, social and intellectual therapies help people retain or rediscover skills or simply gain pleasure from taking part. This is something that is simply not available locally. Such activities have been proven to slow down the worst impacts of this disease and keep families together longer.

Previously we simply did not have the space to support this work but we are now in a position to do so. We have identified a group of specialists/volunteers willing to offer such therapies and to a limited degree these have now begun. However If successful Community Chest funding will enable us to support the development of a full range of new and innovative Music Therapy sessions, Art groups, specialist Exercise classes and reminiscence therapy activities as well as bringing in chiropody services and offering additional carer support activities.

3.2. How does your project contribute towards the Council's Families and Communities Strategy and Families and Communities Approach? Please refer to guidance and reference both in your answer.

This Strategy sets out six main intentions and this Project will we believe contribute to each of them.

> At its heart the Hub is designed to support families and the wider community to help meet the individual needs of people with dementia: Dementia is a progressive disease for which there in no known cure. National and local studies have clearly illustrated the pernicious impact of dementia that too

- often leads to people prematurely needing to leave their home and community because of the scarcity of high quality support services.
- > Our purpose built Hub and our trained and experienced staff can ensure that people are appropriately and safely cared for whilst with us and can offer advice and support to individuals, their carers and the wider community where appropriate
- > Services are and will be designed around the specific needs of individuals
- ➤ People can 'live well with dementia' if given the appropriate care and advice. Too often this has not been sufficiently available leading to family breakdown and people moving out of their home to a more sheltered environment. We can and will with colleagues more frequently help to prevent this happening.
- ➤ Gatehouse has established the Hub in partnership with other voluntary, statutory and private agencies: Its primary purpose is to equip people with dementia to retain or rediscover life skills and to enable carers to identify appropriate caring strategies
- Our vision to establish the Hub began in 2015, progress has been made but there is still much to be achieved. We view the Hub as a community development, not simply a place for people to go to be cared for.

Additional funding will enable us build on the work we have undertaken to date. We will be in a position to establish more Carers will have weekly a group to build local networks of support ongoing: This helps carers, who too often lose friendships and the support of neighbours to take back control of their lives and to feel connected to the community in which they live.

As identified in 3.1 up to 60 people per week, living with Dementia will have an opportunity to partake in activity which will stimulate and maintain skills, which in turn will enable them to improve retain or improve their mental wellbeing and continue to live at home for longer.

We provide respite to Carers of those living with Dementia, which improves their wellbeing: Evidence shows that this reduces appointments with GP'S and other medical services and enables people to look forward to a healthier future for themselves and families whilst continuing to care for loved ones. Currently we provide weekly respite activities for carers and additional funding will enable this figure to rise by a further 10%

Becoming a member of Gatehouse enables people to access services in a safe friendly environment where they can feel a sense of belonging. Users are

encouraged to bring ideas for services and to run their own groups where possible to encourage that sense of ownership.

Apart from maintaining effective case records and statistical information Gatehouse routinely collects feedback from customers and carers in a form appropriate to their needs and understanding.

Organisations supporting the formation of the Dementia Hub are:

Suffolk County Council Adult Care Services, Sue Ryder, Clarke Care, Ageing with Optimism and the Dementia Intensive Support Team: These partnerships enables us to facilitate support groups and run advice and guidance services, drop in café's and other care services.

By having a local independent charity running the Dementia Hub in Bury St Edmunds, it enables the service to be unique in its holistic approach. It reduces wasteful competition amongst organisations and means new and innovative ideas can be explored.

Working together we offer advice and guidance and ways of coping with Dementia. Each person with dementia is an individual and will respond to different settings and therapies. A single named contact it provides easier access to a wider range of services.

NHS England, Armstrong's Funeral Services, White Stuff Foundation, LD Rope- are supporting the financial side of the building work to make our current premises suitable for the needs of our service users.

We will be working with local business in the town to raise awareness and create a Dementia Friendly Community.

3.5. What evidence do you have that there is a need for this project? Please include sources of evidence, including any public/user /community consultation and research you have carried out.

In January 2016 Gatehouse staged a conference on the future of dementia services in West Suffolk. This was attended by 25 organisations across the Adult Social Care and voluntary sector. The outcome was that a Dementia Hub would be created with the object of providing a single point of contact for services post diagnosis through to end of life care. In summary we identified that the locality needed

- > Better Communication between service providers
- > Less 'competition' between services and interaction with local businesses
- Education/Training for carers, professionals and the wider public
- > GP based key workers
- > Use of social media
- > Early intervention/support to avoid crisis
- > Rurality presents isolation and transport issues
- > Support for People with dementia living alone
- Personalised age specific services,
- > Targeted, time specific and easy access to information

We know from feedback from these organisations and more significantly, those living with dementia that the Hub has made a difference to people's lives.

Since we started the development an additional 25 people per week to date have benefitted from the creation of the Hub following the work on our building and the creation of a specialise dementia lead post. The Hub provides a social arena for people to date living with Dementia and their carers to form lasting friendships with those in a similar situation to themselves whilst support groups have brought together people facing similar issues. Previously this support would not have been available to them.. Members of support groups often share experiences and advice. It can be helpful just getting to talk with other people who are in the same situation.

3.6. How has the project been developed out of the community's desire to improve the lives of local people? What role have users and/or the community had in developing this project?

The involvement of users and the local community is part of Gatehouse's founding principles: From the outset, the Dementia Hub has been designed not only with the active involvement of the stakeholders described above but by users and carers.

As a direct result of existing unmet needs the Hub was developed in partnership with the local community namely, other voluntary agencies, Primary, Acute and Secondary NHS services, Social Care, the private sector and neighbourhood groups. Since it's established fruitful and on-going relationships have also been established with local commercial organisations.

Tailored individual and personalised services can only be successfully established with those directly involved taking centre stage. The services described have in the

main come about through what people living with dementia and their carers tell us

Gatehouse for over 30 years has had a track record of creating and running innovative personal services through generating sustainable income.

We will charge for the service which in time will enable the service to become largely self-sustainable, although as a charity we will continue to source additional funding to ensure sustainability.

Most people value a service more when they can make an affordable contribution but we always ensure that we provide good value for money. People are not excluded if they do not have the money.

Examples below are what you can expect to pay at Gatehouse:

Music Therapy - £2.50 pp (1 Hour) Armchair Exercises - £5 pp (1 Hour -refreshments) Lunch Clubs - £ 25.00 Chiropodist Treatment - £25.00
