Overview

Millennium Farm Trust was formed in 1996 to provide adults with additional needs the opportunity to learn skills in construction, agriculture, horticulture and animal husbandry. Since 2015, the Trust has established a sustainable working base at Depden Care Farm, (DCF) a 6-acre smallholding.

The mission of the Trust is to enable everyone with additional needs to be the best they can possibly be by providing learning and work opportunities rarely available elsewhere. Working on the farm improves physical fitness, mental health, social skills and wellbeing and develops knowledge and skills that help participants reach their life goals.

The Artful Farm will provide the opportunity for local people living with mental health difficulties, learning disabilities or other additional needs to use art materials and the creative process to explore their emotions and feelings about their environment and in particular the farm. The appointed artist will deliver arts based workshops.

The artworks created by the artist and by workshop participants will be inspired by the farm and explore our response to its impact on our mental health. Art pieces will be exhibited at the farm as part of Suffolk Open Studies in 2019.

The programme will operate for 30 days over April, May and June 2019 and is being developed in partnership with Suffolk Open Studios, and local special schools in St Edmundsbury.

Millennium Farm Trust was formed in 1996 to provide adults with additional needs the opportunity to learn skills in construction, agriculture, horticulture and animal husbandry. Since 2015, the Trust has established a sustainable working base at Depden Care Farm, (DCF) a 6-acre smallholding.

The mission of the Trust is to enable everyone with additional needs to be the best they can possibly be by providing learning and work opportunities rarely available elsewhere. Working on the farm improves physical fitness, mental health, social skills and wellbeing and develops knowledge and skills that help participants reach their life goals.

DCF provides a safe and supportive learning and working environment. The focus is on supporting recovery and building the resilience of people with mental health problems, learning disabilities or acquired brain injury, as an addition to treating or managing their symptoms.

DCF provides structured activities and opportunities to learn skills in horticulture, animal husbandry and agriculture. Within a formal daily framework, attendees perform routine and seasonal tasks required to maintain the farm. Activities comprise looking after the animals; helping to grow, harvest and prepare fruit and vegetables for sale, helping to maintain and develop the gardens and carryout routine farm maintenance and construction work. In recent months, to provide a bridge to other employment opportunities, external contract work has been undertaken.

Most clients are on the Autistic Spectrum and have moderate to severe learning disabilities accompanied with some motor or coordination difficulties. Working at DCF helps to:

Develop key social skills and cognitive functioning that assists with greater independence and increased social inclusion;

Improve social functioning by maintaining and developing appropriate relationships with friends and colleagues;

Increase self-esteem by the development of new skills and the achievement of key work tasks; and

Improve mood and reduced anxiety.

3. About Your Project

The Artful Farm is a project that will improve the lives of local people, particularly those with mental health difficulties, learning disabilities or other additional needs. Using art materials and the creative process to explore our emotions and feelings about our environment and our farm in particular, the appointed artist will deliver arts based workshops.

As well as developing arts skills in their own right, the artistic process reduces anxiety, increasing self-esteem and helps develop personal insight. Many of the people that come to the care farm find talking about their feelings about their condition difficult. The Artful Farm will provide another avenue for them to express themselves and help inform their time with us. The artworks created by the artist and by workshop participants will be inspired by the farm and explore our response to its impact on our mental health. Art pieces will be exhibited at the farm as part of Suffolk Open Studies in 2019.

The programme will operate for 30 days over April, May and June 2019 and is being developed in partnership with Suffolk Open Studios, and local special schools in St Edmundsbury.

The Artful Farm provides a unique opportunity for partners to work together and enable local people, including those with additional needs to explore their response to the farm in news ways, to socialise and meet new people in a supportive and creative environment. This is the first time that the Trust has used the arts in this way and will support future working and help ensure the sustainability of the provision once funding comes to an end.

The funding will be used to pay an artist, purchase materials, document the created works and market the programme.

3.2. How does your project contribute towards the Council's Families and Communities Strategy and Families and Communities Approach? Please refer to guidance and reference both in your answer.

The 'Artful Farm' project is aligned to the council's strategic priority to maintain resilient families and communities. The main beneficiaries have learning and physical disabilities or are recovering their mental health. These groups are often alienated from mainstream society. The project aims to encourage individuality, reduce dependency and improve employability.

The project reflects the Councils aspirations to maximise an individuals talents to enable them to achieve the best that they can in all aspects of their life and enable them to play a fuller role in society. It will provide stimulation and education. It is aimed at both existing farm helpers and potential clients.

Working with the Artist, farm helpers will experience new ways to express themselves, be given the opportunity to understand their rural surroundings in a very different manner and have the chance to learn practical and life skills.

As encouraged in the Families and Communities Approach (FCA), the project will engage with partners (West Suffolk College, Riverwalk, Priory School and Broadlands Hall). The Artist will host engagement workshops with these institutions to enable their students nearing completion of their education to experience the benefits of working outdoors and increase awareness of the natural world.

Reflecting the FCA the outreach work aims to build the self-confidence of these students who are understandably apprehensive of the changes they are facing. The project will help provide a safe and enjoyable introduction to working life on the care farm. In doing this the Artful Farm' project will form a supportive link with the students, their families and their institutions.

The achievements of the students and farm helpers will be celebrated at a farm open day where the work produced during the project will be presented. As outlined in the FCA this will reinforce both individual and collective achievement.

3.3. How many people will benefit from your project (on a weekly, monthly or annual basis) and how? Please include outcomes (how your project will benefit the people who are involved in it) and how you will collect evidence of this.

Around 465 people will benefit from the Artful Farm project as follows:

- 5 workshops with 12 farm helpers in each = 60 partiicipants
- 3 workshops with schools with 25 children = 75 participants
- 2 workshop with volunteers = 30
- Attenders at open day = 300

The anticipated outcomes for participants include:

- heightened enjoyment, excitement, fulfilment and therapeutic release of tensions
- an increase in skills and knowledge associated with particular art forms
- enhanced knowledge of social and cultural issues
- a new insight into the rural environment
- advances in personal and social development
- development of creativity and thinking skills
- enrichment of communication and expressive skills

Evidence to assess the impact of the project will be collected from feedback from the partner organisations, staff and the artist and by asking participants to complete a short evaluation.

The Artful Farm project will work with key educational partners (**West Suffolk College, Priory School, Riverwalk, Broadlands Hall**) to help highlight the role the care farm can play in the students decision making on the transition to the world of work. They will assist with the workshops run by the Artist on their premises and help with the evaluation of the outcomes.

Suffolk Open Studios, a non-profit making organization run by artists, will promote the outcomes of the project as part of their 2019 Open Studios event where visitors are able to see the artist at work.

There is capacity within the project to engage with local organisations (for example the **Little Teapots pre school, Chedburgh).** The aim of this part of the initiative is to raise disability awareness, help to break down barriers and reinforce positive relationships between the local community and the care farm.

3.5. What evidence do you have that there is a need for this project? Please include sources of evidence, including any public/user /community consultation and research you have carried out.

Demand for placements at the farm is increasing. Since 2015 attendance has tripled to over 1700 user day sessions annually. This growth means that clients have a wider range of interests and abilities. The skills development programme on offer to service users needs to reflect these wider requirements. The 'Artful Farm' project will help to do this.

Nationally there is significant evidence that an Artist in Residence can have a major and lasting impact on the quality of life for people in care situations. The Arts Council promotes the value of this approach and there are many examples of successful projects that deliver long-term benefits. In 2017 Suffolk Art Link ran a programme in care homes. They found that creative interventions impacted positively on the wellbeing of residents and developed confidence and creative skills. The 'Artful Farm' project is a new approach for care farms and is designed to encourage innovation in the way farm helpers perceive their natural environment and learn new skills.

Guardians of farm helpers support this proposal. They feel that it will provide a structured framework and specialist support for the development of new skills that will have lasting benefits for work and social situations.

3.6. How has the project been developed out of the community's desire to improve the lives of local people? What role have users and/or the community had in developing this project?

Working on the Farm builds self-confidence, increases the capacity to cope with the challenges of everyday living and opens up new opportunities for greater independence. Guardians of service users are keen to see the farm offer new learning opportunities to help explore and discover new talents and awareness. They see the Artful Farm initiative as an exciting and new way to do this.

Based on a deep understanding of the capabilities and potential of farm helpers the Artful Farm project has been shaped by the Farms Director who has previous arts experience of delivering similar arts based placements.

The projects partners want their final year students to explore all the next-step life choices available to them. They welcome the project and feel that engaging students in this novel manner will be an effective way of explaining the benefits of outdoor employment.

The Trust is one of a few West Suffolk based SCC accredited suppliers for work placements for clients with special needs. The County Council appreciates the major role the care farm plays in meeting local demand for supported employment and, as is proposed in this initiative, they are keen that the skills of work placements are maximized.
