1. Context to this report

- 1.1 On 14 July 2022, the Overview and Scrutiny Committee considered the following items:
 - 1. Draft West Suffolk Annual Report (2021 to 2022)

 - 3. Work programme update 2022
- 1.2 Note that there is no report from the Committee as a result of its meeting scheduled for 8 September 2022 as this meeting was cancelled.

2. Proposals within this report

- 2.1 Draft West Suffolk Annual Report (2021 to 2022) (Report number: OAS/WS/22/0013)
- 2.1.1 The Leader of the Council attended the meeting of the Overview and Scrutiny Committee and presented the Draft West Suffolk Annual Report (2021 to 2022), which highlighted the key activities and developments that had been achieved over the financial year 2021 to 2022.
- 2.1.2 The Annual Report focussed on the council's achievements over the past year, categorised under the three priorities set out in the West Suffolk Strategic Framework 2020 to 2024, which included support for local communities and businesses as it responds to and begins to recover from the impact of COVID- 19.
- 2.1.3 The final Annual Report would include infographics to provide a strong and easily digestible summary of the council's work over the previous year and was designed to be used in a number of ways, including for briefing materials, social media and parish councils.
- 2.1.4 The Committee examined the document in detail and asked a number of questions of the Leader, to which comprehensive responses were provided. In particular, discussions were held regarding electric vehicle charging points; COVID business grants; the Clinical Commissioning Group; homelessness levels and how families and individuals can be supported to maintain a tenancy; and the UK Shared Prosperity Fund.
- 2.1.5 The following amendments to the Annual Report were recommended by the Overview and Scrutiny Committee:
 - Page 1: reference be made to the council's wider suite of documents that report on the performance of the council, including the Annual Statement of Accounts and performance dashboards. Furthermore, that these reporting routes help the council to understand where we

need to improve, the challenges we face and areas of focus for the future.

- Page 3, eighth bullet point, the figure of 39,000 tonnes of household waste sent for processing at the Energy from Waste facility in Great Blakenham be confirmed.
- Page 8: third bullet point, a link to the Housing Needs Assessment be included alongside a brief overview of the content of the assessment.
- Page 9: third bullet point, include the outcomes from the 1,232 households at risk of homelessness who were provided with advice and support.
- Page 10, add further examples of actions carried out by the council to improve biodiversity

to which officers agreed to look at incorporating into the final document, to be presented to Cabinet.

On 19 July 2022, Cabinet considered and approved the above amendments as an <u>addendum</u> to Report number: <u>CAB/WS/22/039</u> and the draft Annual Report itself attached as <u>Appendix A</u>.
