The prevention of public nuisance.

The premises is currently subject to a Noise Abatement Notice served by the Council's Environmental Health Team on 25 May 2022 under s.80 Environmental Protection Act 1990 in respect of noise nuisance caused by loud music emanating from the premises and amounting to, in my professional opinion, a statutory noise nuisance under the Act by virtue of the music having a significant and unreasonable impact on the ordinary enjoyment of a neighbouring residential property i.e. affecting normal conversation / watching a television played at normal volume and preventing / disturbing sleep. The service of this Notice was based on direct observations of loud music emanating from the licensed premises and having a significant and unreasonable impact on the ordinary enjoyment of a neighbouring property. This Notice has been subject to an appeal and that appeal was dismissed by the Magistrates Court on 31 October 2022 and the Notice therefore upheld.

Since the service of the Notice the applicant appears to have made no attempt to comply with the Notice and complaints continue to be received. The premises remains under active investigation, breaches of the Notice have been witnessed, and further formal action to achieve compliance with the Notice to abate the nuisance is currently under consideration.

The continued operation of this venue would, in my opinion, expose nearby residents to unreasonable disturbance caused by loud music emanating from the premises.

It is unusual for Environmental Health to request a licence review, but in this circumstance, I feel it necessary as a representative of the responsible authority charged with promoting the prevention of public nuisance licencing objective under the Licensing Act 2003 to pursue this action.

Complaints have been received by this team concerning noise from the premises since the venue began operation in April 2022. These complaints state that disturbance is caused mainly on Friday, Saturday and Sunday nights and according to information provided by complainants has occurred most weeks since the operation commenced, although the complainants have also stated that they actively seek to be away from the premises when the opportunity arises to avoid the disturbance.

The Designated Premises Supervisor has been contacted by this team on

multiple occasions in writing advising him of the unacceptable noise levels but has apparently taken no effective action to reduce the level of disturbance.
Despite requests there is no noise management plan in place for this operation and no assessment has been made of the suitability of the structure for use as a music venue in terms of noise and vibration transmission within the building.
