# **Background:**

This application is referred to the Committee because the Local Authority is the applicant.

# **Proposal:**

1. Permission is sought for works to trees as specified in the above description.

#### **Site Details:**

3. The site is situated within the Housing Settlement Boundary and comprises an attractive group of trees within and to the rear of properties on Corsbie Close. The trees are well developed and form an attractive and important feature of the local area forming a boundary between the gardens to the rear of Corsbie Close and the footpath along the River Linnet.

# **Planning History:**

4. None relevant

#### **Consultations:**

5. <u>Tree Officer:</u> All works appear to be reasonable maintenance given the species involved and their location close to the footpath, garages etc and previous management (such as pollarding Willows). The Ash (1302) appears to be suffering as a result of soil level changes. The Goat Willow (1727) is ok and leaning away from the path but ok to pollard.

#### **Representations:**

- 6. Town Council: No objection based on information received.
- 7. No other representations received.

## **Officer Comment:**

8. The application site forms a visually attractive barrier between Corsbie Close and the River Linnet. The footpath winds between the trees which form an avenue and in places creates a tunnel effect for footpath users due to the proximity and low height of some of the trees. One reason for

the works is to provide a safe clearance for pedestrians along this pathway as a number of branches are reasonably low.

- 9. Similarly the crown raising of the Hazel (1346) will provide clearance to garages at the rear of Corsbie Close.
- 10. The remainder of the works are in accordance with standard arboricultural practice and are considered necessary, and acceptable.

#### **Conclusion:**

11. In conclusion the proposal is considered to be appropriate works in line with good arboricultural standards and will contribute to the long term vitality and viability of the trees.

#### **Recommendation:**

It is **RECOMMENDED** that **Approval** be granted subject to the following conditions:

- 1. Standard Time limit.
- 2. Works to appropriate Arboricultural Standard.
